EVENT PURPOSE AND TIMELINE

The purpose of this event is to celebrate the accomplishments and key milestones of the Children's Sickle Cell Foundation, Inc. through its collaborative partnerships over the last 20 years. In addition, the goal is to raise at least \$100,000. Representing the approximately 100K persons living with sickle cell disease in the USA. Most of the proceeds benefit children and adults living with sickle cell disease throughout the Commonwealth of Pennsylvania by providing quality community-based programs, care coordination, and services. A portion of the funds raised will support research that will hopefully lead to a universal cure for sickle cell disease (SCD)

Timeline:

- 1. Establishing the event committee; meeting schedule and marketing plan (May 2022)

- 4. Engaging partners, corporations, community organizations, and foundations for sponsorship opportunities

- 7. Submit post-event reports and send thank you letters/notes. (October 2022)
